## The challenge

- Managing OUD and reducing emergency department (ED) utilization rates related to overdoses are significant challenges for health systems across the nation.
- Patients with OUD require continuous support and timely interventions to prevent relapses and overdoses.
- High rates of ED visits due to overdoses strain healthcare resources and highlight the need for more effective outpatient management and support systems.

- Ophelia seamlessly integrates video-based clinical visits, medication management, and continuous support tailored to each patient's unique needs.
- Each patient receives a personalized treatment plan based on evidence-based practices, ensuring the most effective care and support for their circumstances.
- With its proprietary EMR and analytics capabilities, Ophelia can provide health systems with actionable insights to improve patient outcomes, track progress, and adjust treatment plans as needed.



#### The success


- ✓ Patients engaging with Ophelia's virtual care services demonstrate significantly higher levels of engagement in treatment and adherence to treatment plans, resulting in over 70%¹ retention of insured patients at 180 days and total cost of care savings of about 60%².
- Health systems utilizing Ophelia's platform can generate substantial decreases in ED visits related to opioid overdoses, easing the burden on emergency services and improving patient safety.
- Ophelia's model helps health systems achieve significant cost savings by preventing relapses and reducing hospital readmissions while delivering high-quality care.

OUD is treatable. We need to expand access. Only 5% of patients are receiving any MOUD within 7 days of hospital discharge despite the fact that it is proven to significantly reduce the chances of overdose. At Ophelia, we are eager to partner with health systems - both outpatient facilities and acute care hospitals - to provide care continuity and help these patients stay healthy."
